

Iowa Mandatory Reporting Requirements Regarding Children

Who Must Report?

Mandatory Reporting:

- Every health practitioner who examines, attends, or treats a child and who reasonably believes the child has been abused, including a health practitioner who receives information confirming that a child is infected with a sexually transmitted disease, including:
 - o Licensed physician and surgeon;
 - o Osteopathic physician and surgeon;
 - o Dentist;
 - o Optometrist;
 - o Podiatric physician;
 - o Chiropractor;
 - o A resident or intern in any of such professions;
 - o A licensed dental hygienist;
 - o A registered nurse or licensed practical nurse;
 - o A physician assistant; and
 - o An emergency medical care provider.
- Any of the following persons who, in the scope of professional practice or their employment, examines, attends, counsels, or treats a child and reasonably believes a child has suffered abuse, and:
 - o A social worker;
 - An employee or operator of a public or private health care facility;
 - A certified psychologist;
 - A licensed school employee, certified para-educator, holder of a coaching authorization issued by the state, or an instructor employed by a community college;
 - An employee or operator of a licensed child care center, registered child development home, Head Start program, Family Development and Self-Sufficiency Grant Program regulated by the state, or Healthy Opportunities for Parents to Experience Success-Healthy Families Iowa Program;
 - An employee or operator of a substance abuse program or facility licensed by the state;
 - An employee of a Department of Human Services institution regulated by the state;

	 An employee or operator of a juvenile detention or
	juvenile shelter care facility approved by the state;
	 An employee or operator of a foster care facility licensed
	or approved by the state;
	 An employee or operator of a mental health center;
	 A peace officer; and
	 A counselor or mental health professional. A "mental
	health professional" is a person who:
	 Holds at least a master's degree in a mental health field, including, but not limited to, psychology, counseling, nursing, or social work; or is licensed by the state to practice medicine; Holds a license to practice in the appropriate profession; and
	Has at least two years of post-degree experience, supervised by a mental health professional, in assessing mental health problems and needs of individuals used in providing appropriate mental health services for those individuals.
	• An employee or operator of a provider of children's services
	funded under a federally-approved waiver.
	Permissive Reporting:
	Any other person who believes that a child has been abused.
Standard of Knowledge	Reasonable belief that a child has suffered abuse.
Definition of Applicable	A child means any person under the age of 18. A mandatory
Victim	reporter must report abuse of a child under the age of twelve, and may report the abuse of a child under the age of eighteen, except that the abuse resulted from the acts or omissions of a person other than a person responsible for the care of the child.
Reports Made To	Mandatory reports shall be made both orally and in writing.
Reports Made 10	Permissive reports may be made orally, in writing or both.

Iowa Mandatory Reporting Requirements Regarding Children	
Contents of Report	 Services within 48 hours after the oral report. The oral and written reports shall contain as much of the following information as possible: The name and home address of the child, the child's parents, or other people believed to be responsible for the child's care; The child's present whereabouts if not the same as the parents or other person's home address; The child's age; The nature and extent of the child's injuries, including any evidence of previous injuries; The name, age and condition of other children in the same home; Any other information which the person making the report believes might be helpful in establishing the cause of the injury to the child, the identity of the person or persons responsible for the injury, or in providing assistance to the child; and The name and address of the person making the report.
Timing/Other Procedures	Reports shall be made within 24 hours.
Other	 Mandatory reporters whose employment or self-employment involves the examination, attending, counseling, or treatment of children on a regular basis shall complete two hours of training relating to the identification and reporting of child abuse. The training must be completed within six months of initial employment or self-employment. The person shall complete at least two hours of additional child abuse identification and reporting training every five years.
