There is an **exception to privilege** in any proceeding in which the client's mental, physical or emotional condition is used as an element of the claim or defense. In this case, the court may order an examination of the condition of the client, which may require access to otherwise privileged information.

Applicable in whole or in part in the following states:

- Alaska
- District of Columbia
- Hawaii
- Kentucky
- Louisiana

Other common exceptions to privilege:

- Disclosure to protect the client or another individual from a substantial risk of imminent and serious physical injury
- Mandatory reporting of suspected child abuse or neglect and adult child abuse or neglect
- Client is about to commit a crime
- Service of the victim advocate or counselor were sought in order to aid any person to commit or plan to commit what the client knows or reasonably should have known is a crime or fraud
